

NEXGEN GATHERING SCHOLARSHIP APPLICATION

Eligibility criteria:

1. A member of and demonstrates involvement in the FPA of Minnesota including the NexGen community at either the local or national level.
2. An early-career CFP® certificant or is working towards becoming a CFP® certificant.
3. Furnishes a complete application including essays and letter of support.
4. Submits a letter of recommendation by a FPA MN member (not a member of the NexGen committee)
5. Is willing and able to attend and participate in all scheduled events at the FPA NexGen Gathering **June 2-4 at Loyola University in New Orleans, LA.**
6. Has not attended a past NexGen Gathering conference (must be a first-time attendee).
7. Is willing and able to write a one-page article (or visual equivalent) describing your experience at the conference which may be used in future FPA marketing promotions.
8. Is willing to attend a brief awards ceremony.

Financial need is not a consideration; merit is. Limit of one scholarship per individual. Recipient enrollment for the conference, including pre-conference workshop, if applicable and on-site lodging will be paid by FPA of MN. Recipient will receive reimbursement of up to \$500 for transportation including reasonable airfare and ground transportation after both attending the conference and submitting a summary of your experience as described in the Eligibility criteria. Decisions to award a scholarship shall be made at the full discretion of the FPA of MN NexGen committee whose members are not eligible for the scholarship. If awarded the scholarship and you do not attend you will be billed \$474 for conference enrollment paid by FPA of MN.
